Research activities at Unicaf University in Zambia An Update by Dr Marirajan Thiruppathi Deputy Vice-Chancellor, Research & Innovation, Unicaf University in Zambia

National Symposium Unveils Ground-breaking Recommendations for Dementia Care in Zambia

After two years of dedicated collaborative training and research on Focused Intervention Training and Support (FITS) on dementia care between the University of Huddersfield, UK, Kanyama General Hospital, and Unicaf University in Zambia, the National Symposium on the outcome of FITS Training/Research Program in Dementia Care took center stage on the 19th of January 2024, in Lusaka.



The symposium, well attended by 47 participants including academics, health professionals, stakeholders, and members of the public, served as a platform for unveiling groundbreaking insights and outcomes derived from the comprehensive FITS (Focused Interventions Training & Support) program.

The event commenced with an impactful inaugural address by Dr Christine Phiri Mushibwe, Vice Chancellor of Unicaf University in Zambia, emphasising the enduring impact of collaborative efforts on person affected by dementia. Dr

Marirajan Thiruppathi, Deputy Vice-Chancellor for Research and Innovation, then provided an insightful overview of the symposium's objectives, setting the stage for a day filled with enlightening sessions.

Theme I: FITS Program Implementation: Challenges and Opportunities moderated by Dr Clement Chela, Dean, School of Health and Applied Sciences of Unicaf University in Zambia, this session delved into the challenges and opportunities encountered during the implementation of the FITS program at Kanyama Hospital. Dr Rooke presented the results, offering a comprehensive understanding of the intricacies involved.

Theme II: Impact Assessment Case Studies by DCCs under the moderation of Masozi, Dementia Care Coaches (DCCs) presented four impactful case studies by Dr Thomson Lukisa, Dr Thando Agape Dube, Mr. Franklin Munsanje and Mr. Mills M. Mulale, covering various clinical diagnosis and management of person affected by dementia. The interactive question-and-answer session that followed allowed for engaging discussions and knowledge exchange.


Theme III: Best Practices and Innovations moderated by Dr Daniel Mpolomoka, Dean, School of Education Humanities and Social Sciences of Unical University in Zambia, this session showcased best practices and innovations in dementia care. Presentations by Dr Thiruppathi, Dr Albert Tambeke, Ms. Emily, and Dr Mbono Dube provided valuable insights into online focus groups, innovative approaches, and challenges faced by non-medical DCCs.

Theme IV: Panel Discussion on Policy Implications of FITS Program. The symposium concluded with a thought-provoking panel discussion moderated by Dr Lameck Mwewa, Deputy Vice-Chancellor of Unicaf University in Zambia. The panel, comprising experts such as Dr Rooke, Dr Wilson Mbewe, Dr Thirrupathi, and Mr. Glan.

The panelists discussed future directions, advocating for continued research collaboration, policy advocacy, and the integration of FITS principles into broader healthcare frameworks.

Key Policy Recommendations:

- Community Awareness and Stigma Reduction: The symposium recognized the prevailing stigma associated with dementia, particularly in rural communities where patients are sometimes treated as victims of witchcraft. The importance of creating awareness was underscored, emphasising the need for targeted community engagement initiatives. Capacity building should extend to faith-based organisations, involving church priests and traditional healers to dispel myths and promote understanding of dementia.
- Policy Implications: The existing national policy on elderly persons lacks specific provisions addressing dementia care. The symposium highlighted the imperative to advocate for policy amendments or dedicated policies that comprehensively address the unique needs of dementia patients. This involves incorporating FITS principles into healthcare policies to provide a structured and supportive framework for dementia care initiatives.



• Integration of FITS into Higher Education Institution Academic Curriculum: To ensure the sustainability and widespread adoption of FITS principles, the symposium proposed the integration of the FITS curriculum into existing academic programs. This includes medical, nursing, clinical medicine, and social work curricula. By incorporating dementia care education at the academic level, future healthcare professionals would be better equipped to address the unique challenges posed.



In conclusion, the National Symposium successfully disseminated valuable insights, case studies, best practices, and policy implications.

The collaborative efforts between institutions and the active engagement of participants contributed to advancing dementia care standards and fostering a holistic understanding challenges and opportunities in the field.

Research Day event: Research discussion on the Identification Research Gaps and Opportunities in Dementia Care Research in Africa

On January 12, 2024, Unicaf University in Zambia held a significant Research Day event, where Dr Rooke, Senior Lecturer in School of Nursing Science, Huddersfield University, UK, delivered an enlightening presentation on the critical gaps in dementia care research specific to Zambia and Africa. Dr Rooke's presentation focused on identifying key research gaps, shedding light on critical areas that need attention within the context of dementia care in Africa. Some of the highlighted gaps included the limited policy framework, an emphasis on communicable diseases, insufficient resources, issues of stigma and awareness, workforce capacity, integration into general health systems, caregiver support, and challenges related to research and data collection.

The interactive session, attended by 12 faculty members representing diverse disciplines such as the School of Health and Applied Sciences, Management, and Social Sciences, provided a platform for fruitful discussions. Dr Rooke not only outlined the existing gaps but also underscored potential areas of opportunity for collaborative research and publication among faculty members.

The engagement featured brainstorming exercises related to presentation's theme, fostering a collaborative environment for addressing the identified gaps and

advancing research in dementia care within the academic community.

Doctoral Insights: A Conversation with Our Accomplished Graduate

Mini interview with our doctoral graduate Dr Edward Kalisa

Dr Edward Kalisa brings over two decades of extensive expertise encompassing policy formulation, strategic planning, research, and project management. Currently serving as the Secretary General of Rwanda Governance Board (RGB) since April 2016, he oversees the effective implementation and monitoring of RGB's programs. ensuring excellence in service delivery and promoting good governance principles. As the Chief Accounting Officer, (CAO) Dr Kalisa actively engages in fund raising and resource optimization. His prior roles include serving as Permanent Secretary for the Ministry of Sports and Culture and the Ministry of Youth. A recent PhD in



Business Administration from the Unicaf University in Zambia complements his academic

achievements, including a Master of Arts in Organizational Leadership and degrees in Management from esteemed institutions.

Q: Reflecting on your doctoral journey, what key insights or lessons did you gain throughout the completion of your PhD, and how have these experiences shaped your perspective as a researcher?

EK: Given the nature of my work, I was initially skeptical that I would not get time to study PhD but later, I realised that, everything we do in life is a matter of choice. The flexible nature of Unicaf University PhD program also allowed me to keep hope that the journey was worth taking. I have realised that, there are always ways to achieve what we want as long as we make a decision and devise strategies to put the decision into action. The PhD journey has changed the way I manage time and I will never say that I cannot do this or that, because I am busy. I learnt that everything we do or fail to do depends on the importance we attach to it.

Q: As a recent doctoral graduate, can you share specific challenges you faced during your research and the strategies you employed to overcome them, ultimately leading to the successful completion of your PhD?


EK: Undertaking a project like a PhD is not something easy; it requires total re-organisation of one's lifestyle. The first thing I had to do was to be more organised than I had been and to be very strict in managing time. So, this necessitated re-organising my life to ensure that I manage work, studies and get time for my family. Part of the re-organisation also demanded that I make exercising part of my life schedule. Regular workout made a very big difference; it helped me remain healthy and fit in the midst of the extremely busy schedule. I also came to learn that every situation however bad it may be leaves something positive both to individuals and collectively. COVID-19 was one of the most tragic pandemics the world has ever had; it consumed many lives, threatened everyone and changed the world order. With all the challenges that came with COVID-19, I took advantage of the numerous lockdowns where work was almost at a standstill to do a big part of my thesis. I completed the parts that required a lot of reading and writing that would otherwise have been difficult during the normal situation.

Q: Looking ahead, how do you envision applying the knowledge and skills acquired during your doctoral studies in your future career or within your academic pursuits? What areas or projects are you particularly passionate about exploring?

EK: What I do in my current role involves a lot of research and the skills gained from my PhD program have enabled me to make contribution to the research we do. I believe the skills gained will continue to help me make significant contribution to the research work we do in the institution I work for. Skills gained will also help me continue doing publications on a number of areas especially those related to service quality and Rwanda's home grown solutions.
